In accepting his citation Chaplain Vandervaart encouraged the Board to continue with the Chaplaincy ministry. We have a very unique program as we have a number of Chaplains and the service is covered 24/7. He thanked the Board for the opportunity to be involved.

Chief Poole advised that there is another resignation of Reverend Dave Fuller. He has been a Chaplain with the Chatham Kent Police Service since March of 2008 and he has participated in one of our Board Chaplain training days in the spring of 2010 and the Peace Officers Memorial Service, our own

4.8 Presentation Y.I.P.I. – Summer Students.

Chief Poole advised that the Youth In Policing Initiative involves students who we have the pleasure of having with us for the summer. This year we have four students for a period of eight weeks. The program is provided through the Ministry of Children and Youth Services.

Cst. Jon Mulder provided an overview on the program and introduced the four students who have been working in various departments. The students are Raymond Moore, Noah Perritt, Ashley White and Rochelle Bowles. The students are in the I.S. Department, Traffic and Media, Quartermasters, Training. There is also a partnership with CK Learning.

Ashley provided a presentation which she prepared for the Board, explaining the positions each student participated in.

Chief Poole thanked the students although they still have until the end of August to complete the program. However since the Board will not be meeting again until September this was the only opportunity to have them appear before the Board and to thank them for being with us for the summer.

The Mayor commented that this a presentation that should be made to Council as well.

5. **Reports from Deputy Chief:**

5.1 ComCentre Q2 Statistics

Deputy Chief Wiersma commented on the 911 hangup calls from cell phones. He said that this is an ongoing problem. He said that a 911 hangup is not just forgotten, they attempt to track it down. These hang-ups take a lot of time and effort to process. Often the calls that are made in error are due to pre-programmed phones that have 911 as a one button push and most often that button is pushed in error. In an attempt to eliminate this problem one button push from their cell phones.

The Chief advised that this is a problem all across the Province, Canada and the United States.

Councillor Stirling commented that it may be easier to educate Blackberry to take it right off the equipment.

Chief Poole advised that basically this is what is coming. They may take that whole emergency feature off the phone.

The Mayor said he agreed with Councillor Stirling that this should not be an automatic push, it should be a 911 call.

The Mayor suggested that the Board should request the Chiefs to request cell phone distributors to remove the emergency push button feature from their phones
