## RECOMMENDATION FOR CHIEF'S COMMENDATION

To: Chatham-Kent Firefighter Jozlyn LANTIN and Mr. Joseph NEUFELD.

**RE: Courageous Assistance – December 29, 2019 – CK19066729**

On Sunday, December 29<sup>th</sup>, 2019 at approximately 4:11pm, Chatham-Kent Police received a call regarding a motor vehicle collision on Wheatley Road and Hornick Line. A 56 year old male driver lost control of his vehicle while travelling south and rolled the vehicle into the east side ditch, which was filled with approximately 50cm of water. The vehicle landed on its roof and the driver was trapped inside.

Mr. Joseph NEUFELD was an eyewitness to the collision. He called 911 immediately and entered the ditch to render assistance. He was forced to break the driver's side window to access the driver and through conversation with him, was able to provide valuable information to emergency services. Chatham-Kent Firefighter, Jozlyn LANTIN, arrived shortly thereafter and entered the ditch prior to the rest of her team arriving. She secured the driver's head, keeping it from entering the water. Fire and ambulance arrived shortly thereafter at which time the driver was extricated and transported to the Chatham campus of the Chatham-Kent Health Alliance, where he was treated for his injuries.

In the face of adversity, and extreme environmental elements, both Ms. LANTIN and Mr. NEUFELD exemplified courage, compassion and teamwork, all of which represent core values of our Service. These actions fully demonstrate the Community-Police relationship we strive to build.

As a result of their courageous and quick actions, you are both being recognized by way of a **Chief's Commendation**.

The award will be presented to you at the upcoming Police Services Board meeting to be held on Tuesday January 21, 2020 at the Civic Centre. I sincerely hope that you will be able to attend the meeting in order that you may be appropriately recognized at that time.

**Overview**

In 2017, the Chatham-Kent Police Service incorporated policy and procedures surrounding the Collection of Identifying Information in Certain Circumstances (CIICC) as per Regulation 58/16 of the Police Services Act.

As part of this regulation, the Chief of Police shall provide the Police Services Board an annual report. The annual report shall include statistical data related to the collection of identifying information. Below is the data related to the collection of identifying information for the Chatham-Kent Police Service in 2019.

Throughout 2019, officers with the Chatham-Kent Police Service did not interact with members of our community that would have initiated CIICC documentation. In medium to smaller communities such as Chatham-Kent, the general public would come to expect that their police service is well aware of the criminal sub-culture. As such, members of the Chatham-Kent Police Service (throughout 2019) conducted 3,186 Person Stops and 2,804 Compliance Checks with known individuals, subsequently not meeting the mandate as outlined under the Regulation 58/16 of the Ontario Police Services Act. At no time during these interactions, did officers gather new identifying information from the individuals involved.

These interactions are created to track the day-to-day activities of our officers; it also allows the service to pro-actively engage members of our community. Typically these interactions could be related to, community engagement, criminal investigation, traffic enforcement, intelligence lead policing, proactive policing, or simple observations.



### **Overview**

In 2019 officers with the Chatham-Kent Police Service went above and beyond the call of duty. In the reports below, each officer acted in a manner that deserves special recognition. As such, Cst. Jeff Teetzel, Cst. Mark Charron and Cst. Jason Hamm are receiving Deputy Chief Letters of recognition, for their professionalism, honesty, integrity and courage.

#### ***Cst. Jeff Teetzel- Project Fresh- Court Disposition 2019***

In October 2018 the Chatham Kent Police Service Drugs/Intelligence Section started Project "FRESH". The focus of the project was to infiltrate the criminal element involved in drugs and property crimes at specific problem areas identified within Chatham Kent. It was determined that the most appropriate form of investigation was through the use of undercover operators and human sources developed by members of the Drugs/Intelligence Section. As a result of this decision project "FRESH" was initiated.

Over the course of the project there was 6 search warrants executed, 19 arrests, 82 charges and over 3.2 million in Controlled Drugs Seized. One significant case proceeded to court for disposition. Detective Constable Teetzel was the lead investigator on this file. In the normal course of business all drug exhibits and currency seized as a result of the investigation are forfeited to the crown upon successful prosecution of the accused. In this case, Detective Constable Teetzel took the unconventional road and requested that the currency seized be placed in an education trust for the children of the accused. This request was agreed to by the crown, defence and the presiding judge.

As a result of Detective Constable Teetzels "out of the box" approach to disposition in this file the estranged children of the accused will benefit; if they so choose, with a tremendous head start with the relief of a financial burden associated to post secondary education. This empathetic approach is indicative of the professionalism that Detective Constable Teetzel continues to exhibit time and time again.

**Cst. Mark Charron and Cst. Jason Hamm-Drugs and Weapon Arrest/Seizure 2019**

On the 28<sup>th</sup> of December, 2019, Officers Mark Charron and Jason Hamm were conducting a RIDE program in the City of Chatham, Municipality of Chatham-Kent.

At approximately 11:27pm on this date the officers observed a blue Chevy Impala make an abrupt turn from the RIDE program, which caused the officers to believe the vehicle and its operator were attempting to avoid police. The officers located and stopped the vehicle, which had a lone male occupant. Officers could smell an odor of marihuana coming from the inside of the vehicle and they also observed a small clear plastic baggy with suspected marihuana.

The male exited the vehicle, and quickly reached into his the waist area of his pants. Officers quickly took physical control of the male, and after a brief struggle the male was detained. Officers located on the male a clear plastic baggy, containing 41 grams of methamphetamine. Upon a further search officers located in the male's waistband, a loaded 22. Caliber ISS M22 (Glock style) hand gun. A further search of the vehicle, officers located ammunition for said firearm. The male party does not have a license to possess a firearm and in fact is on 2 separate prohibition orders, prohibiting him from possessing any firearm. The firearm was being carried in a careless manner and it is believed the male party possessed the firearm for a purpose dangerous to the public or for committing a criminal offence.

Through further investigation officers observed that the serial number was removed from the chamber of the firearm. Upon further analysis officers were able to locate a serial number on the frame of the firearm and learned that the firearm had been reported stolen from the Lambton area in 2018 as a result of a break and enter. The male party was charged with one drug offence and twelve weapons offences, he was held for bail.

The officers in this instance, used their training and keen eye to locate, charge and arrest an individual with a long criminal history. Further, these officers were able to remove a handgun as well as illicit and dangerous drugs from our streets.
