The CKPS incorporated policy and procedures in 2017 surrounding the Collection of Identifying
Information in Certain Circumstances (CIICC) as per Regulation 58/16 of the *Police Services Act*.
The annual report includes statistical data related to the collection of identifying information.
Throughout 2020, officers with CKPS did not interact with members of our community that would have initiated CIIC documentation. The CKPS conducted 1,595 person stops with known individuals, at no time during these interactions did officers gather new identifying information from the individuals.
The interaction are typically related to community engagement, criminal investigation, traffic enforcement, intelligence lean policing, proactive policing, or simply observations.
