BACKGROUND

As per Sec. 81 (1) and O. Reg. 603/20 of the Community Safety and Policing Act (CSPA) if an investigation is conducted by the Special Investigations Unit (SIU), the Chief of Police shall investigate,

- a) The member's conduct in relation to the incident;
- b) the policing provided by the member in relation to the incident; and
- c) the procedures established by the chief of police as they relate to the incident.

In a letter dated December 9, 2025, SIU Deputy Director Stacey O'Brien notified the Chatham-Kent Police Service (CKPS) Chief of Police that SIU file #25-OSA-352 had been terminated and a report regarding the matter would not be issued.

Below is a review of the incident and relevant parallel investigation conducted by the CKPS.

INCIDENT SUMMARY

On August 29, 2025, the complainant was arrested on multiple charges and later experienced a medical emergency while in police custody. While in hospital, it was learned that the complainant had reported being sexually assaulted by a CKPS officer several years ago. Upon receiving this information, the officer notified their supervisor. CKPS reported the disclosure to the SIU, who invoked section 15 of the SIU Act, resulting in an investigation.

SIU FINDINGS

In a letter dated December 9, 2025, the SIU advised they have terminated their investigation and that no report would be issued on this matter.

INTERNAL INVESTIGATION / CONCLUSION


In accordance with Section 81 (1) and O. Reg. 603/20 of the Community Safety and Policing Act, The Chief of Police is required to complete a thorough internal investigation into the incident and review; member's conduct, the policing provided by the member and the procedures related to the incident. This section outlines obligations related to transparency, accountability and compliance. The CKPS investigation was initiated to meet these responsibilities.

The Professional Standards Branch conducted an internal investigation to ensure transparency, accountability and compliance. As a result of this investigation, the following findings were made:

- Disclosure was promptly reported to Supervisors and Professional Standards. (CKPS Procedure – LE.09.004 – SIU Investigations).
- SIU was contacted by the CKPS SIU liaison officer, CKPS continued to assist their agency as required. (CKPS Procedure – LE.09.004 – SIU Investigations)



Within seconds, Sergeant Fraser Leontowicz arrived on scene and while exiting his patrol vehicle was met by the mother, holding her son, who was pale with blue lips and unresponsive.


The infant was immediately handed over to Sergeant Leontowicz who immediately started CPR and rescue breaths on the infant child. Sergeant Leontowicz's life saving efforts were successful resulting in the infant regaining consciousness.


