The Deputy Chief presented the report on the Board Citation- Next Generation 911 (NG 911) Implementation Team.

On December 1, 2025, the Emergency Communication Centre (ECC) for CKPS and the Municipality of Chatham-Kent, officially cut over to the Next Generation 9-1-1 platform. The project has been in motion for over three years and required countless hours of planning, coordination, and rigorous testing- especially in the past few months leading up to a successful implementation.

The completion of the NG911 project represents a significant advancement in emergency communications, enhancing location accuracy, multimedia data handling, and interoperability with provincial systems. The project also included the construction of a fully functional secondary ECC ensuring 24 hour 9-1-1 capabilities in the event of a significant outage.

The dedication and perseverance shown by the team have been nothing short of exceptional. Every Team Member put their heart and soul into this project. We are very appreciative that each one of you made to get this projected completed on budget and to make our community safe.

In recognition of their professionalism, dedication, and teamwork in implementing NG911 the Board would like to recognize the team for their outstanding work and dedication to the project by presenting the team with a board citation.

4.2 Canada Federal Assault-Style Firearms Compensation Program

The Chief presented the report on the Canada Federal Assault-Style Firearms Compensation Program. After a thorough review, it was determined the CKPS will not be participating in this program. Our commitment is to ensure organizational resources remain focused on priorities and initiatives that most effectively enhance public safety and support the well-being of the residents of Chatham-Kent.

The CKPS acknowledges the Federal Governments continued efforts to address gun violence and the CKPS will work with our partners both federally and provincially to combat illicit firearms. It is not mandatory to participate in this program; we have received support from the community in support of our service for not participating in the program.

Mr. Sulman- I do not have a question but a comment-Congratulations from removing the service from this boondoggle. The Chief advised, both the OAPC and International do not support the program. We do not mind participating and helping because we agree with the removal of illicit firearms, but we believe it is targeting lawful gunowners and not the illegal firearms that we should be targeting. We believe if the money is going somewhere, it should be for more officers on the ground targeting those guns coming across the border and getting them off the streets.

#### 4.3 Inspector General of Policing- Province Wide Review

The Chief presented the report on Inspector General of Policing- Province Wide Review. The Inspector General of Policing (IG) announced on February 9, 2026, that all 45 police services in the province of and their boards, including the Ontario Provincial Police , will be reviewed by an external investigator.

The investigation will focus on five defined areas:

- How officers are supervised and how effective that supervision is
- Screening and vetting of police officers both at recruitment and on an ongoing basis as they move through their careers.
- Access to police databases and information systems
- Evidence and property management practices
- Substance abuse and fitness for duty

The CKPS welcomes the review launched by the Inspector General of Policing, recognizing that the process strengthens accountability, reinforces integrity, and enhances public trust going forward.

The review aligns closely with the CKPS 2025-2028 Strategic Plan, which prioritizes trust-building, transparency, modernization, and strong community partnerships. CKPS maintains robust systems, policies and oversight mechanism yet remain steadfast in its responsibility to ensure that corruption never has an opportunity to take root.

We are committed to building trust through transparency, fair practices, and a culture where accountability is embraced, not avoided. Our community has high expectations- and we welcome that. The CKPS is committed to meeting those expectations every day through professionalism, ethical conduct and a constant respect for the trust our community places in us. CKPS have already begun preparing the required documentation and proactively evaluating any potential vulnerabilities.

In a letter dated January 9, 2025, SIU Deputy Director Stacey O'Brien, notified the CKPS Chief of Police that SIU file# 25-OCI-412 had been concluded and a reporting there were no reasonable grounds to proceed with criminal charges against the subject officer.

A parallel investigation was conducted by the CKPS Professional Standards Branch to ensure transparency, accountability, and compliance. The investigation included a review of the following procedures:

- Crisis Negotiations (ER-02-001)
- Unmanned Aerial System (UAS) (ER-02-011)
- Conducted Energy Weapons (AI-04-014)
- Prisoner Care and Control (LE-03-003)
- SIU Investigations (LE-09.400)-SIU Investigations was promptly notified by the CKPS Liaison Officer, and the Service cooperated fully with the investigation in accordance with established procedures.

Based on a review and analysis of all available information with respect to the incident, the Professional Standards Branch has determined that all police procedures related to the incident were in keeping with legislation and written such as providing adequate and appropriate guidance to its member.

**BACKGROUND**

On August 6, 2019, Mr. Humphrey was transported to the Chatham-Kent Health Alliance, by Emergency Medical Services (EMS) and the Chatham-Kent Police Service. Mr. Humphrey was in medical distress after consuming an unknown substance. Mr. Humphrey became vital signs absent while being treated at the Chatham-Kent Health Alliance and was subsequently pronounced deceased by Dr. Huffman. Due to the involvement of Police, a mandatory inquest was ordered.

Dr. Elizabeth Urbantke, Regional Supervising Coroner for the West Region, London Office, called a mandatory inquest into the death of Thomas Martin Humphrey pursuant to section 10(4.6) of the Coroners Act.

The inquest was conducted virtually commencing on October 15, 2025, and concluding on October 23, 2025.

The jury sat for seven days, heard evidence from 10 witnesses, reviewed 22 exhibits.

## **JURY RECOMMENDATIONS/CKPS ACTIONS**

At the conclusion of an inquest, the chief coroner will send the jury's recommendations to named organizations. Recipients of the recommendations are asked to respond to the chief coroner within six months outlining how they have considered the recommendations. While not legally binding, recommendations are aimed to improve safety.

The jury returned a verdict that Mr. Humphrey's death was accidental, the jury did not assign criminal or civil liability but focused on identifying opportunities to prevent future deaths in similar circumstances.

The jury issued ten recommendations, four of which (Recommendations 3, 4, 5, and 8) were directed to the Chatham-Kent Police Service (CKPS). The following summarizes those recommendations and the actions undertaken by CKPS.

### **Recommendation 3:**

Chatham-Kent Police Service (CKPS) should ensure that annual use of force training addresses various circumstances and the associated risks of the application of force to an individual's heads and neck area, including the use of pressure points. Such training should include instruction about circumstances that may limit the options for use of force to the head and neck area. The training should include the idea that use of force in the head/neck area be excluded in cases where the person to whom force is being applied is experiencing severe agitation in a medical situation.

**Action taken:** CKPS consulted with the Ontario Police College and reviewed its Use of Force training to ensure alignment with current OPC standards, with specific attention to risks associated with head and neck control, including during medical crises. Officers are expected to assess the totality of the situation, consider alternatives, limit duration, and apply force that is reasonable and proportionate to the associated risk.

### **Recommendation 4:**

CKPS should review and consider the evidence heard at this inquest, and any material in its possession relating to Thomas Humphrey's death, with a view to considering policy and training improvements.

### **Action taken:**

CKPS completed a review of the evidence presented at the Coroner's Inquest, together with relevant internal materials related to the death of Thomas Humphrey. This process was undertaken as an organizational learning initiative to identify opportunities for improvement in policy, training, and operational practice. The review also ensured policy and training is aligned with legislative requirements, and provincial standards. As a result, the policies and training material below were updated.

- AI 04 015 – Conductive Energy Weapon
- LE 07 004 – Prisoner Transport
- LE 03 003 – Prisoner Care and Control
- AI 04 002 – Use of Force
- LE 01 003 - Note Books
- LE 09 004 - SIU Investigations
- AI 01 016 – OPIOD Overdose response

**Recommendation 5:**

CKPS should review and revise its policies with respect of the use of the term “Excited Delirium” to ensure that terminology and guidance is consistent with the latest understandings of persons experiencing severe agitation.

**Action Taken:**

CKPS has completed a comprehensive review of all relevant policies and training materials. The term “excited delirium” has been removed and replaced with “persons in medical crisis,” with corresponding updates incorporated into the Use of Force training curriculum to ensure consistent terminology across all training platforms. CKPS also consulted with the Ontario Police College to confirm alignment with current instructional standards. The following Policies have been updated:

- AI 04 015 – Conductive Energy Weapon
- LE 07 004 – Prisoner Transport
- LE 03 003 – Prisoner Care and Control
- AI 04 002 – Use of Force

The terms “Medical Crisis” and “Extreme Agitation” are now formally defined in Procedure AI 01-001 – Glossary.

**Recommendation 8:**

Chatham-Kent Police Service (CKPS), CK Emergency Medical Services (CKEMS) and the Chatham-Kent Health Alliance (CKHA) should establish and maintain an ongoing process of collaboration to develop, implement, and periodically review a framework outlining their respective roles and responsibilities when addressing a person experiencing severe agitation.

**Action taken:**

Partner agencies have developed a framework that clearly defines each organization’s roles and responsibilities when responding to individuals experiencing a medical crisis. CKPS has formally adopted the “Response Strategy when Encountering Persons in a State of Medical Distress” as a standard response protocol. The agencies have committed to ongoing joint reviews to ensure the framework remains effective, current, and aligned with best practices, supporting safe and consistent responses.

**CONCLUSION:**

The jury's recommendations provide an opportunity to further strengthen public safety, inter-agency collaboration, and community trust, particularly in high-risk medical response scenarios.

The Chatham-Kent Police Service has carefully reviewed the findings and recommendations and has taken necessary steps in response. Through comprehensive policy review, enhanced and updated training, the removal of outdated terminology, and strengthened inter-agency collaboration.




